This application and the Rule Book (collectively "Application") shall be governed by and interpreted in accordance with Local, State and Federal Laws, without reference to or application of principles of choice of law. In any proceeding arising from or related to the enforcement and/or interpretation of this application, the Indemnified Party as prevailing party shall be entitled to recover its cost which includes reasonable attorney's fees, against the non-prevailing party. No modification, alteration, waiver or change in any of the terms of this application shall be valid or binding upon the Indemnified Party unless made in writing and duly executed by the Indemnified Party from whom a waiver is sought. The provisions for this application shall be severable, and if any of them are held invalid or unenforceable for any reason, such provision shall be adjusted to the minimum extent necessary to cure such invalidity. The invalidity or unenforceability of one provision shall not affect any other.
